



The Summary of Benefits and Coverage (SBC) document will help you choose a health [plan](#). The SBC shows you how you and the [plan](#) would share the cost for covered health care services. **NOTE:** Information about the cost of this [plan](#) (called the [premium](#)) will be provided separately.

What is the overall deductible ?	Network providers: \$1,700/individual, \$3,400/individual under family or \$3,400/family Out-of-network provider: \$3,400/individual, \$3,400/individual under family or \$6,800/family	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. The deductible is Non-Embedded . If you have other family members on the plan , the overall family deductible must be met before the plan begins to pay.
Are there services covered before you meet your deductible ?	Yes. Preventive care services are covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive care without cost-sharing and before you meet your deductible . See a list of covered preventive services at https://www.healthcare.gov/coverage/preventive-care-benefits/ .
Are there other deductibles for specific services?	No.	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan ?	Network providers: \$3,400/individual, \$6,800/individual under family or \$6,800/family Out-of-network providers: \$6,800/individual, \$6,800/individual under family or \$13,600/family	The out-of-pocket limit is the most you could pay in a year for covered services. The out-of-pocket limit is Non-Embedded . If you have other family members on the plan , the overall family out-of-pocket limit must be met.
What is not included in the out-of-pocket limit ?	Premiums , balance billing charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .

Does this plan provide Minimum Essential Coverage? Yes
